# **CHAPTER 10.01**

# NATIONAL PARKS ORDINANCE

(Ordinances 11 of 1975, 10 of 1989, 12 of 1992, 4 of 2005, 26 of 2016 and 2 of 2017)

AN ORDINANCE TO PROVIDE POWERS TO PERMIT THE ESTABLISHMENT OF PARKS, NATURE RESERVES, SANCTUARIES AND AREAS OF HISTORICAL INTEREST, AND GENERALLY FOR THE CONSERVATION OF THE NATURAL ENVIRONMENT AND ECOLOGY OF THE ISLANDS AND FOR PURPOSES CONNECTED THEREWITH.

# Commencement

[30 October 1975]

## Short title

1. This Ordinance may be cited as the National Parks Ordinance.

# Interpretation

2. In this Ordinance—

"area of historical interest" means an area declared to be of historical interest under section 3;

"court" means the Magistrate's Court;

- "critical habitat reserve" means a critical habitat reserve established under section 3; (Inserted by Ord. 26 of 2016)
- "development" includes any change in use, the erection of any structure and the carrying out of any drainage, dredging or sewerage scheme, and such other activities as may be prescribed by the Governor by order;
- "Director" means the Director of Environment and Coastal Resources; (Inserted by Ord. 26 of 2016)
- "enforcement officer" means a conservation officer, police officer and a fishery officer as defined under regulation 3(1) of the Fisheries Protection Regulations; (Inserted by Ord. 26 of 2016)

"national park" means a national park established under section 3;

"nature reserve" means a nature reserve established under section 3;

"private land" means any land the title to which is vested in any person other than the Crown or the Government;

"sanctuary" means a sanctuary established under section 3.

# Declaration of national parks, etc.

3. (1) The Governor may by order declare any area in the Islands, including any part of the territorial waters of the Islands, to be—

- (a) a national park;
- (b) a nature reserve;
- (c) a sanctuary;
- (d) an area of historical interest; or
- (e) a critical habitat reserve. (Amended and inserted by Ord. 26 of 2016)

(2) For the purposes of the Logwood (Hotel) Development Agreement dated 22 April 2003, the Governor may, by order declare that from a specified date the limits of the Pigeon Pond and Frenchman's Creek Nature Reserve shall be altered or varied in the manner specified in that order.

(Amended by Ord. 4 of 2005)

- (3) The Governor may by Order—
  - (a) alter or vary the boundary of any national park, nature reserve, sanctuary, area of historical interest or critical habitat reserve;
  - (b) declare a national park, nature reserve, sanctuary, area of historical interest or critical habitat reserve to cease to be a national park, nature reserve, sanctuary, area of historical interest or critical habitat reserve; or
  - (c) declare a change in the classification of a national park, nature reserve, sanctuary, area of historical interest or critical habitat reserve. (Inserted by Ord. 26 of 2016)

(4) The Director shall first give notice in the *Gazette* and in at least one newspaper in national circulation of the proposed establishment, alteration, variation or cessation of a national park, nature reserve, sanctuary, area of historical interest or critical habitat reserve. *(Inserted by Ord. 26 of 2016)* 

(5) Any person may, within six weeks of the notice referred to in subsection (4), make either oral or written representation on the proposed establishment, alteration, variation or cessation of a national park, nature reserve, sanctuary, area of historical interest or critical habitat reserve, to the Director. (Inserted by Ord. 26 of 2016)

(6) The Governor shall not make an order under this section, unless the draft has been laid before the House of Assembly and is approved by the House of Assembly. (*Inserted by Ord. 26 of 2016*)

## Usage of national parks, etc.

4. (1) Subject to any regulations relating to any particular national park or nature reserve—

- (a) an area which is designated as a national park shall be open to members of the public for recreational use, including camping, fishing and sailing, and the Governor may make a grant of development permission for the erection in the area of buildings, the construction of roads, marinas and such other development as may be considered to be desirable to facilitate enjoyment by the public of the natural setting of the area and any features of historical interest therein; but in considering whether or not any such development as is mentioned in this paragraph as being permissible shall be authorised in any particular case, the paramount consideration shall be to limit such development to the minimum consistent with the reasonable access to and enjoyment of the area by members of the public; and
- (b) an area which is designated as a nature reserve may be used for agricultural, arboricultural, piscicultural, catch-and-release bonefishing, sporting and recreational purposes, subject to such restrictions as may be prescribed and which may be considered desirable to ensure a proper balance in the natural ecology of the area; but no building or other development shall be permitted except in accordance with the conditions of a grant of development permission made by the Governor and such grant shall only be made for a building or other development which is required for one of the aforesaid uses which are permissible in a nature reserve.

## (Amended by Ords. 10 of 1989 and 26 of 2016)

(2) The declaration of an area as a sanctuary shall be made primarily for the purpose of the protection of the natural ecology, or of any particular form of living organism (including any marine life), in the area, and the avoidance of disturbance of the area by human beings, either at any time or at particular times according to the circumstances and the form of life which it is desired to protect; and entry into a sanctuary shall not be permitted except in accordance with any regulations made in respect of that sanctuary and no person shall carry out any development in a sanctuary.

(3) The declaration of an area of historical interest shall be primarily for the purpose of protecting an object of historical interest in the area; and such an area may form part of a national park, nature reserve or sanctuary, and in such case shall be subject to those provisions of this section and any regulations which are applicable to that park, reserve or sanctuary, and in the case of any other area of historical interest, the public shall have access to the area, or to any object of interest in the area, during such times and subject to such conditions as may be prescribed by regulations which are applicable to that area; and no person shall carry out any development in that area except under a grant of development permission made by the Governor.

# (Amended by Ord. 10 of 1989)

(4) The declaration of an area as a critical habitat reserve shall be made primarily for the purpose of the protection of any endangered species, including its habitat in any wetlands, pine woodlands, caves and other karst features and tropical dry forest and no person shall carry out any development in that area unless—

- (a) an environmental impact assessment is conducted by an independent, qualified and credible environmental professional;
- (b) the environmental impact statement recommends that the development proceed;
- (c) the grant of development permission incorporates terms, conditions and limitations that address the environmental impact assessment, subject to a "no net loss" of habitat value; and
- (d) a grant of development permission is made by the Governor. (Inserted by Ord. 26 of 2016)

(5) Sections 78, 79 and 80 of the Physical Planning Ordinance apply with such modifications as the circumstances require to applications for development permission in a national park, a nature reserve, a sanctuary or an area of historical interest or a critical habitat reserve as they apply to applications for development permission in a conservation area made under the Physical Planning Ordinance: (*Amended by Ord. 26 of 2016*)

Provided that the Director of Planning appointed under the Physical Planning Ordinance shall make available to the Minister responsible for this Ordinance a copy of the environmental impact statement referred to in those sections before any application for development permission is approved. (Inserted by Ords.10 of 1989 and 12 of 1992)

# Provisions with respect to land in areas declared to be national parks, etc.

5. In any case in which private land is included in any area which has been declared to be a national park, a nature reserve, a sanctuary, an area of historical interest or a critical habitat reserve and the Governor does not consider that it is necessary for the purpose to which the declaration relates to acquire such land

under the Land Acquisition Ordinance, any person entitled to any interest therein shall be entitled to receive compensation from the Government for the diminution, if any, in the value of his interest consequential upon any restrictions imposed on his use of the land by reason of such declaration; and if agreement cannot be reached between the Government and the party concerned as to whether or not any compensation is payable, or as to the amount thereof, the matter shall be referred to arbitration under the Arbitration Ordinance. *(Amended by Ord. 26 of 2016)* 

# Restriction on certain activities harmful to the ecology

- **6.** (1) If the Governor is satisfied that—
  - (a) it is, or is likely to become, necessary for the prevention of the pollution of, or any other harmful or disturbing effect or influence on, the natural ecology of any national park, nature reserve, sanctuary or critical habitat reserve; or (*Amended by Ord. 26 of 2016*)
  - (b) the preservation of any particular form of living organism (including vegetable or marine life) in any part of the Islands so requires,

the Governor may by order impose restrictions on any development or the depositing or discharge of any waste or harmful matter in any area which he considers would have direct or indirect harmful effect on such natural ecology or living organism.

(2) The provisions of section 5, with respect to the assessment and payment of any compensation, shall apply with such modifications as the circumstances require in the case of any diminution in the value of any interest in land by reason of any restrictions imposed by order made under this section.

# Enforcement

- 7. (1) A person who—
  - (a) carries out any development in a national park, nature reserve, sanctuary or area of historical interest or critical habitat reserve, except in accordance with the terms of a grant of development permission made under section 4; or (*Amended by Ord. 26 of 2016*)
  - (b) fails to comply with any restriction imposed by an order made under section 6; or
  - (c) enters any sanctuary without authority,

commits an offence and is liable on summary conviction to a fine of \$50,000 dollars or to imprisonment for a term of twelve months, or to both. *(Amended by Ords. 10 of 1989 and 12 of 1992)* 

(2) The court before which a person is convicted under this section may order the demolition of any structure erected or the reinstatement of anything altered or removed in contravention of subsection (1), and in default of compliance with any such order of the court, the Governor may cause the necessary work to be carried out and may recover as a civil debt the cost of so doing from the person in default.

(3) An appeal shall lie to the Supreme Court from any decision or order of the Magistrate's Court made under this section.

# Regulations

**8.** The Governor may make regulations for carrying into effect the purposes and provisions of this Ordinance and such regulations may provide—

- (a) for the control and management of national parks, nature reserves, sanctuaries, areas of historical interest, critical habitat reserves; (Amended by Ord. 26 of 2016)
- (b) the conditions subject to which members of the public shall be permitted to enter and use any national park, nature reserve, area of historical interest, or critical habitat reserves, and for the issue of licences to permit persons to enter any national park, nature reserve, sanctuary, area of historical interest, or critical habitat reserves for any particular purpose; (Amended by Ord. 26 of 2016)
- (c) for the regulation and control of prohibition of any hunting or fishing in or the removal of any living organism or any substance from any national park, nature reserve, sanctuary, area of historical interest, or critical habitat reserves; (Amended by Ord. 26 of 2016)
- (d) for the appointment of persons as—
  - (i) conservation officers and for conferring on such conservation officers powers to enforce the regulations; or
  - (ii) volunteer conservation officers to assist in conservation, education and outreach activities;
- *(e)* that a contravention of a provision of the regulations constitutes an offence and for a penalty on summary conviction in respect of such contravention of—
  - (i) a fine of \$50,000 or imprisonment for a term of twelve months, or both; and
  - (ii) in the case of a continuing offence, a fine of \$100 for every day or part of a day on which the offence continues;
- (f) power for a court to order a person convicted of an offence referred to in paragraph (e) to pay the cost of repairing any damage to a national park, nature reserve, sanctuary, area of historical interest, or critical habitat reserves caused by the commission of the offence; (Amended by Ord. 26 of 2016)
- (g) power for an enforcement officer to arrest without warrant any person whom the enforcement officer reasonably suspects to be committing, to have committed or to be about to commit an offence against the regulations or this Ordinance, and for the

seizure or forfeiture to the Crown of any article used in the commission of any such offence or alleged offence; (Amended by Ord. 26 of 2016)

- (h) power for an enforcement officer to initiate proceedings for offences against the regulations; (Substituted by Ord. 26 of 2016)
- (i) for the imposition of fees and charges in respect of any matter with regard to which provision is made in the regulations or in this Ordinance; (Amended by Ord. 12 of 1992)
- (*j*) for the prohibition of specified conduct in any national park, nature reserve, area of historical interest or critical habitat reserve;
- (k) for the discharge of liability for any offence specified under paragraph (j) by a fixed penalty; and
- (*l*) power for an enforcement officer to issue a ticket for the discharge of liability by payment of a fixed penalty for any offence specified under paragraph (*j*). (Inserted by Ord. 26 of 2016)

## **NATIONAL PARKS ORDER – SECTION 3**

(Legal Notices 40/1992, 35/1995 and 3/2006)

Made by the Governor under section 3 of the National Parks Ordinance

## Commencement

[7 August 1992]

#### Citation

1. This Order may be cited as the National Parks Order.

#### **Formation of national parks**

2. The areas named and described in the first column of Part I of the Schedule are declared to be national parks for the protection or promotion of the corresponding features of interest specified in the second column.

#### Formation of nature reserves

**3.** The areas named and described in the first column of Part II of the Schedule are declared to be nature reserves for the protection or promotion of the corresponding features of interest specified in the second column.

#### **Formation of sanctuaries**

4. The areas named and described in the first column of Part III of the Schedule are declared to be sanctuaries for the protection or promotion of the corresponding features of interest specified in the second column.

#### Formation of areas of historical interest

5. The areas named and described in the first column of Part IV of the Schedule are declared to be areas of historical interest for the protection or promotion of the corresponding features of historical interest specified in the second column.

#### Site plans

**6.** (1) The areas described in the Schedule are delimited on site plans designated NP 1–11, NR 12–22, S 23–26 and HA 27–33, that may be inspected at the offices of the Department of Environment, Heritage and Parks during normal working hours.

(2) In a case of inconsistency between the description of an area in the Schedule and its delimitation on a site plan, the former shall prevail for all purposes of interpretation.

#### 6. Fort George Land and Sea National Park:

Comprising an area of 1220 acres north of Pine Cay bounded on the south-east side by a line some 500 feet from Grouper Cay from grid reference ZV 029 232 to ZV 023 221, on the south-west side by the northern edge of a channel to YV 991 231, a straight line to the reef wall at YV 984 243, along the reef wall to YV 995 254, a straight line to ZV 003 242, along the Fort George cut via straight lines to ZV 010 238, ZV 014 236, ZV 018 237, ZV 029 234, and back to the start. Grid references are to sheet 4 Series E8112 (DOS 309P) Edition 2-OSD 1984.

#### 7. Grand Turk Cays Land and Sea National Park:

An area of 386 acres south-east of Grand Turk comprising the whole land area of Gibbs, Penniston and Martin Alonza Pinzon Cays off Grand Turk and the surrounding 400 ft of sea in each case.

#### 8. North West Point Marine National Park:

An area of 2535 acres in Providenciales bounded by the north-west side of Wheeland Cut from the high water mark at grid reference YV 769 188 to the reef wall, along the reef wall to a point at grid reference YV 763 225, along the reef wall to grid reference YV 731 134 approximately north-west of Wiley Point, to Wiley Point; and along the high water mark to the starting point. Grid references are to sheet 2 Series E8112 (DOS 309P) Edition 2-OSD 1985.

# 9. Princess Alexandra Land and Sea National Park:

An area of 6532 acres in Providenciales bounded by a line taken due north of Blue Mountain (C42) from the high water mark to the reef wall, along the reef wall to a point approximately due north of the most westerly point of Water Cay, approximately due south to a point some 1000 ft away from the most westerly point of Water Cay, east 500 ft along the southern coast of Water Cay to YV 972 177 a straight line south to YV 962 150 along the shoreline of Mangrove Cay to Leeward-Going-Through Point, along the high water mark to the starting point. Grid references are to sheet 3 Series E8112 (DOS 309P) Edition 2-OSD 1985.

#### 10. South Creek National Park:

An area of 183 acres in Grand Turk bounded by a line across the mouth of South Creek extending along the coast to the north of Materson's Point, along the northern boundary of Parcel 10411/4 and the western boundary of Parcel 10411/3 until this meets a wall, in a south-westerly direction along the wall to the south side of the road to Materson's Point, along the south side of this road in a westerly direction until its junction with a track, leading to the eastern end of Grand Turk Airport, along the east side of this track around the end of the runway to the canal leading from Hawks Pond Salina to South Creek. Around the Crown land holdings 10505/5 and 6 comprising mangroves and wetlands following the west side of the track ending at South Creek; then in an easterly direction to the starting point and excluding Parcel 10410/3 Eves Hill which is in private ownership.

# **NATIONAL PARKS REGULATIONS – SECTION 8**

(Legal Notices 41/1992, 4/1994, 18/1994, 59/2013, 39/2014 and 25/2018)

#### Commencement

[7 August 1992]

## Citation

1. These Regulations may be cited as the National Parks Regulations.

#### Interpretation

- 2. In these Regulations—
- "access lane" means a vessel or vehicle right of way within and perpendicular to the shoreline for access to and egress from the shore;

"anchoring zone" means a zone established under regulation 6(1)(f);

"animal or plant" means any marine or land vertebrate or invertebrate or animal product, whether living or dead, and any marine or land plant or plant product whether living or dead, including marine products as defined in the Fisheries Protection Regulations;

"aquatic sports zone" means a zone designated under regulation 6(1)(c);

[Subsidiary Legislation]

"area of historical interest" means an area so declared and described in the National Parks Order;

- "artefact" means any human-made object on land or in the sea that is of anthropological, historical or artistic value, including carvings and drawings in, or on, rock, carved stone and pottery shards;
- "beach games" means games and recreations normally associated with recreational beaches and adjacent waters, other than those specifically excluded by these regulations;
- "camping zone" means a zone established under regulation 6(1)(g);
- "charter vessel" means any seagoing sail or motor-powered vessel licensed or approved for hire to carry people;

"Director" means the Director of Environment, Heritage and Parks;

- "Director of Planning" means the Director of Planning appointed under the Physical Planning Ordinance;
- "dive operator" means a person providing snorkel or scuba diving facilities for other persons, involving entry into, or exit from the water by means of a vessel;
- "dive vessel" means a vessel operated by a dive operator, when such vessel is actually involved in dive work, including the transportation of divers to and from the dive site;
- "DOE" means the Department of Environment, Heritage and Parks;
- "engineless vessel" means any seagoing apparatus with no onboard engine and powered by only human effort, including canoes, kayaks, surfboards and non-motorized dinghies;
- "fishing zone" means a zone established under regulation 6(1)(j);
- "fixed DOE buoy" means a DOE numbered white with blue stripe buoy, or any buoy with DOE approved markings that has been installed in a site approved by the DOE;
- "form" means a form prescribed in Schedule 1;
- "hovercraft" means a self-propelled motorized sea craft that rides on a cushion of air, capable of motion on both land and sea;
- "jet ski" means (regardless of the trade name of the vessel concerned) a motor vessel propelled by a water jet—
  - (a) capable of carrying a maximum of four persons; and
  - (b) having a maximum length of ten feet; (Amended by L.N. 18/1994)
- "motor vehicle" means any self-propelled wheeled vehicle, including cars, trucks, motorcycles, scooters and all terrain vehicles (ATV);
- "motor vessel" means any apparatus propelled, or capable or being propelled, on the sea by use of an onboard or outboard motor, including sail vessels containing motors;
- "national park" means an area so declared and described in the National Parks Order;
- "nature reserve" means any area so declared and described in the National Parks Order;
- "Park Warden" means a person referred to in regulation 13(1) or (2);

"parking zone" means a zone established under regulation 6(1)(h);

"permanent mooring" means a mooring with a suitable attachment for securing a mooring buoy set into or laid on the sea bed solely for that purpose and incapable of movement in normal circumstances;

"rescue vehicle" or "rescue vessel" means a vehicle or vessel approved by the Director for use in rescue under regulation 4;

"sail vessel" means a wind surfer, boat or ship propelled on the water by the wind;

"sanctuary" means an area so declared and described in the National Parks Order;

"shoreline" means that part of any national park, nature reserve or sanctuary comprising the foreshore and sand-dunes immediately adjacent to the sea;

"swimming zone" means a zone established under regulation 6(1)(*a*);

"training zone" means a zone designated under regulation 6(1)(d);

"vessel" means any vehicle which travels on water and includes ships, boats, dinghies, windsurfers, jet skis and any motorized vessel;

"wall" means the fifty-fathom depth isobath on the seaward boundary of any national park;

"water ski" means a ski or ski-like apparatus used in gliding behind a power vessel over the surface of the water;

"zone" means a zone, access lane or right of way established under regulation 6.

#### Prohibitions and permitted activities

- **3.** (1) The following are prohibited within all national parks—
  - (a) the taking of any animal or plant by any method on land or at sea, except to the extent permitted in any fishing zone;
  - (b) the taking of any artefact;
  - (c) the destruction of, or damage or injury to, any animal or plant;
  - (d) the removal of sand, rock, coral, coral-rag or any calcareous substance, except where such removal is necessary to maintain traditional use and access to an established navigational channel, dock or marina; (Amended by L.N. 59/2013)
  - (e) anchor damage to coral reef structures living or dead and associated marine plant and animal life;
  - (f) the anchoring of vessels greater than sixty feet in length other than in an anchoring zone;
  - (g) jet skis and hovercraft, other than a hovercraft approved or permitted under regulation 8 to operate in a national park; (Amended by L.N. 59/2013)

(5) No person, other than a Park Warden acting in the course of his duties, shall use or have in his possession within a national park, nature reserve, sanctuary or area of historical interest any type of firearm, air gun, spear gun, cross bow, bow and arrow or other similar weapon.

(6) Subject to subregulations (1), (2) and (4), the following are permitted within national parks, nature reserves and areas of historical interest-

- (a) pedestrian access routes designated by the Director;
- (b) vessels, subject to—
  - (i) their not entering the swimming zones except if they are rescue vessels, fisheries vessels, police vessels, or DOE vessels engaged in placing, repairing, replacing or removing fixed DOE buoys or performing rescue, but provided that persons involved in such operations cause no unnecessary damage to the environment within the zone and that the vessels leave the swimming zone upon completion of the operation within the zone;

## **Rescue vehicles and vessels**

- 4. The Director may, in writing, approve any—
  - (a) motor vehicle to be used as a rescue vehicle;
  - (b) motor vessel to be used as a rescue vessel,

within any national park, nature reserve, sanctuary or area of historical interest.

#### Emergencies

5. No prohibition on anchoring imposed by these regulations shall apply in an emergency, during the currency of a hurricane warning or when permission is given by the District Commissioner or Harbour Master to a specific vessel in circumstances which, in the opinion of such person, constitute an emergency.

#### Zones

6. (1) The Director may establish within a national park or nature reserve, the following zones exclusively for the purposes permitted within such zones—

- (a) swimming zones, where—
  - (i) bathing, swimming, snorkelling and scuba diving other than from a vessel, beach games and other ancillary pursuits are permitted;
  - (ii) all vessels, including engineless vessels, except those exempt in regulation 3(6)(b), are prohibited;
- (b) access lanes where—
  - (i) access and egress by vessels and vehicles, other than those specifically prohibited from use within the national park or nature reserve, are permitted to and from the shore for the purpose of launching, recovery, loading, unloading, embarkation and disembarkation of such vessels;
  - (ii) a vessel or vehicle speed in excess of five mph and access or egress other than at right angles to the shoreline is prohibited;
- *(c)* aquatic sports zones where sailing, windsurfing, canoeing, kayaking, swimming, snorkelling, scuba diving from a vessel and other ancillary activities are permitted;
- (d) training zones where the training of persons for scuba diving or snorkelling is permitted;
- (e) water-ski zones not less than 100 yards from a shoreline where the use of water skis and aqua slide equipment for sport, and the transit of all vessels including engineless vessels is permitted;
- (f) anchoring zones where the anchoring of vessels greater than sixty feet in length is permitted;
- (g) camping zones where camping is permitted;
- (*h*) parking zones for the purpose of parking vehicles while in the proximity of a national park, nature reserve or area of historical interest;

- *(i)* entry right of ways for the purpose of providing controlled access to a national park, nature reserve or area of historical interest;
- (j) fishing zones where, subject to the Fisheries Protection Regulations, noncommercial recreational fishing from the shoreline or from the piers or jetties within the zone is permitted, using light tackle of not more than 30 pounds breaking strain.

(2) There are established within the national park, nature reserve, sanctuary or area of historical interest specified in the first column of Schedule 2 the zones described opposite thereto in the second column of the Schedule.

(3) The Director may, subject to any conditions specified by him, establish within the same area of a national park or nature reserve all or any combination of the zones mentioned in subregulation (1). (Inserted by L.N. 18/1994)

#### Dive vessels and charter vessels

7. A dive vessel or charter vessel shall only be permitted within a national park or nature reserve subject to the conditions that—

- (a) the owner or operator of the vessel applies in form NP2 for a licence in form NP3 permitting him to operate within the national park or nature reserve;
- (b) the vessel moors only to fixed DOE buoys approved by the Director;
- (c) the vessel does not enter the swimming zones unless permitted under regulation 3(6)(b)(i);
- (d) the vessel anchors only in clear sandy bottom; and
- (e) the owner or operator of the vessel pays the fees referred to in regulation 11.

## Hovercraft

**8.** A hovercraft shall only be permitted within a national park or nature reserve subject to the condition that—

- (a) the owner or operator of the vessel applies in writing to the Director for permission to operate it within the national park or nature reserve;
- (b) the vessel is used to provide passenger ferry service only (recreational use is prohibited); and
- (c) the owner or operator of the vessel pays the fees referred to in regulation 11. (Inserted by L.N. 39/2014)

#### Provisions as to new and existing buoys and leasing of buoys

**9.** (1) Subject to the terms of a Development Order made under the Encouragement of Development Ordinance before the date of commencement of these regulations, from that date—

- (a) no buoys shall be installed before prior approval in writing has been obtained from the Director;
- (b) buoys approved under paragraph (a) shall become the property of the Crown; and

(c) no anchoring shall be permitted within 300 feet of a dive site mooring buoy.

(2) An individual, or owner or operator of a dive vessel or charter vessel, may apply to the Director in form NP4 to lease single-user buoys that are not dive site mooring buoys.

## Specimen and artefact collection

10. Notwithstanding regulation 3, the Director may grant a written permit to scientists to collect—

- (a) animal and plant specimens within a national park, nature reserve, sanctuary or area of historical interest;
- (b) artefacts from a national park, nature reserve or area of historical interest,

subject to any conditions specified in the permit relating to the maximum number of specimens or artefacts that may be so collected and the prohibition or restriction of their export.

## Fees

11. (1) The Minister responsible for the Ordinance shall, not more than once a year, approve a tariff of fees to be charged—

- (a) for the issue of a permit pursuant to regulation 3(3)(a) or regulation 10;
- (b) for the making of an application under regulation 7(a), 8(a) or 9;
- (c) for the lease of a single-user buoy pursuant to regulation 9(2);
- (d) to an owner or operator of a dive vessel, charter vessel or hovercraft operating within a national park or nature reserve;
- (e) to a dive operator for each scuba dive or snorkel trip made by clients of such operators; and
- (f) for such other activity carried on for gain within a national park or nature reserve as the Minister may determine. (Amended by L.N. 39/2014)
- (2) The fees referred to in—
  - (a) subregulation (1) may, from time to time, be published by notice in the *Gazette*, but liability for their payment shall not depend on such publication;
  - (b) subregulation (1)(d) shall be chargeable in advance in relation to the length of the vessel used and payable by crossed cheque to the Director;
  - (c) subregulation (1)(e) shall be chargeable in arrears in relation to the number of divers using a specified dive site per year and payable by crossed cheque to the Director before the 1 January of the succeeding year.

(3) The owner or operator of a dive vessel or charter vessel shall, in making payment under subregulation (2), furnish the Director with a return in form NP5A or NP5B, as appropriate. *(Substituted by L.N. 18/1994)* 

#### Returns

12. Regardless of whether a tariff of fees has been approved under regulation 11(1), every owner or operator of a dive vessel or charter vessel operating within a national park or nature

reserve shall, within seven days of the end of the preceding calendar month, make a return in respect of that month in form NP5A or NP5B, as appropriate. (Inserted by L.N. 18/1994)

#### Enforcement

**13.** (1) These regulations shall be enforced by Park Wardens appointed by the Governor, after considering recommendations made by the Director.

(2) A person appointed as a Police Officer and any person appointed as a Fisheries Officer shall be deemed to be a Park Warden for the purpose of these regulations.

- (3) A Park Warden or officer referred to in subregulation (2) shall have the power-
  - (a) to enter all parts of a national park, nature reserve, sanctuary or area of historical interest for the purpose of preventing the commission of an offence under regulation 14;
  - (b) to arrest without warrant any person committing such offence or whom the Park Warden or officer reasonably suspects to be committing, to have committed or be about to commit such offence; and
  - (c) to seize any article, item or thing of whatever kind that he reasonably suspects has been used in the commission of such offence until the determination of proceedings in respect of that offence.

#### Offences and penalties

14. (1) A person contravening regulation—

- (a) 3(1)(d), (e) or (i);
- (b) 3(2)(c), (d) or (g);
- *(c)* 3(3);
- (d) 3(4)(c), (d), (e) or (h); or
- *(e)* 3(5),

commits an offence and is liable on summary conviction to a fine of \$50,000 or to imprisonment for a term of twelve months, or to both.

(2) A person contravening any other provision of these Regulations that imposes a duty of compliance, commits an offence and is liable on summary conviction to a fine of \$5,000 or to imprisonment for a term of six months, or to both.

(3) If an offence under subregulation (1) or (2) is a continuing one, the person convicted of it is liable to a further fine not exceeding \$100 for every day or part of a day on which the offence has continued.

(4) The court before which any person is convicted of an offence under this regulation may order—

(a) the forfeiture to the Government of any item, article or thing used in the commission of the offence;

(b) that the person so convicted pay the cost of repairing any damage to a national park, nature reserve, sanctuary or area of historical interest caused by the commission of such offence.

(5) An item, article or thing forfeited pursuant to subregulation (4)(a) shall be destroyed, unless the Governor in Cabinet directs that it be disposed of in some other specified manner.
